## Private Underground Facilities and/or Hazards

It is your responsibility to mark sprinkler systems, sewer, or water lines, drain tiles, underground electrical wiring, lawn lighting or underground pet fencing, etc. Also, any power lines beyond your meter must be identified.

I agree to locate, mark and clearly identify all private facilities prior to the start of underground construction activities. I understand that failure to locate and mark all facilities could result in damage to those facilities.

I understand that, in the event of damage to facilities that I did not clearly locate and mark, Meeker Energy is not responsible, and I agree to hold Meeker Energy harmless for any damage to any such facilities.
